Birchmont registration will follow upon receipt of Day Camp registration. You **WILL NOT** be guaranteed a place in Birchmont until the executed enrollment form and \$1000.00 deposit is received and acknowledged by the Birchmont office.

Transportation to and from camp on the same bus route is included in the camp tuition. If a camper requires a second bus route on a regular basis, there will be a \$500.00 transportation surcharge per child added to the tuition cost.

*Additional trip charge will be added for Senior & Super Senior campers. These campers have completed the 3rd grade and above. 8 week option - \$300.00; 7 week option - \$275.00; 6 week option - \$250.00; 4 week option - \$200.00

Agreement:

- A check for \$1000.00 per child must accompany this registration form. An additional \$1200.00 per child installment is payable on January 1st 2011, with balance due in full on April 1st 2011.
- > Deposit fees will be refunded (less \$300.00 processing fee) due to cancellation prior to April 1st 2011.
- > There will be no refunds after April 1st 2011.
- There will be a 5% tuition discount for two in a family and a 10% discount for three or more in a family. This discount also applies to combination Day Camp/Birchmont tuitions on the **Day Camp account only.**
- ➤ Sibling discounts will ONLY apply if payment is received in full by April 1st 2011.
- > The parent, guardian or person who signs this agreement represents that he/she has full authority to do so and will be responsible for payment of all camp fees.
- We reserve the right to cancel this registration if fees are not paid in full by April 1st 2011, or if any unforeseen circumstances should arise. Pierce reserves the right to dismiss a camper whose conduct or influence, in the opinion of the Director, is not in the best interest of the camp.
- In the event of delinquent payment, you agree to pay all costs incurred during the collection process, including legal fees. A 1% per month late charge will be added to all past due accounts.
- > It is understood that no credit will be given for camp closings, absences, family vacations, transportation delays or withdrawals.
- A 5-day deductible tuition refund plan is in effect for absence due to illness. Refunds will be made <u>after five (5) consecutive days of</u> absence. A Physician in writing must verify this. No refunds will be made for any non-consecutive absences.
- Consent is hereby granted for transportation to and from any and all camp activities and programs.
- It is understood that all photography or video taken at Pierce may be used for promotional purposes or in other ventures directly relating to the camp.
- The arbitrator and not any federal, state or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable.
